New Business:

Alijah reports that he would recommend new (better) vehicles for Animal Control be purchased in 2016 due to the condition that the current vehicles are in. In addition plows would be beneficial for these units for city assistance.

Alijah advised that he and Jason would like to have city tags sold on the year that animal owners purchase their rabies vaccine, there's a 1 year shot and a 3 year shot. The issue would be to give the option of a one year tag for \$3 or a 3 year tag for \$9 (or at a discount). Dr. Bailey suggests that this wouldn't be a

good idea because people forget about the one year shot...would be worse for a 3 year shot and not likely that people will purchase the 3 year.

Discussion of the purpose for the "City Tag" – Benefits MCAC in regards to identifying the owner of a loose animal, good to have in bite cases, and reduces the impound timeline which saves resources.

Alijah mentioned that he's working with City IT, Andy Matanic in regards to getting access to the tag records stored on the "city drive" for convenience.

Via the hospital in conjunction with the District 1 (FEMA) Team, we received a new trailer stocked with supplies for Emergency Animal Rescue/Shelter at no charge and it will be housed in Michigan City.
