## **DISPOSITION OF GREIVANCE – Michigan City Fire Department Local 475**

Corporation Counsel, John Espar presented the disposition of a grievance; stating the hearing was held by Executive Session on September 8, 2009.

## **ENGINEERING DEPARTMENT UPDATES**

Bill Phelps, City Engineer addressed the Board and reported the following:

Walker Street Improvements – Mr. Phelps reported to the Board the project is complete, except for hydro-mulching the lawn areas, placement of the surface asphalt and completing the final punch list.

Coolspring Avenue Reconstruction – Mr. Phelps reported to the Board that the well point de-watering system at White Oak Drive and Coolspring Avenue has had trouble lowering the elevation ground water therefore the sub-contractor outsourced a different system. Mr. Phelps also reported that the storm sewer installation West of White Oak Drive and Coolspring Avenue is continuing.

Village Green Subdivision Pavement Improvement Project – Mr. Phelps informed the Board that Phase I, pouring of concrete pavement is complete. Mr. Phelps stated that Phase II, excavation of the existing pavement and drive-way approaches along Lexington will commence on October 7, 2009; and Phase II, excavation of the pavement and approach drive-ways on the remaining part of Broadbrook will commence on October 12, 2009. Mr. Phelps explained the type of concrete, as "high early strength concrete", that will be used for Phase II. Mr. Phelps reminded the Board that the only exception for not getting done will be the weather.

## **ADDITIONAL BUSINESS**

Mr. John Chalikian, 609 Franklin Street addressed the Board stating he will do whatever the city expects of him in regards to the cleaning up and fixing of his property at 1203 E. 2<sup>nd</sup> Street. Mr. Chalikian expressed his concerns and issues with how the City handles the surrounding properties.

Mr. Metzcus reminded Mr. Chalikian that the City is only addressing the property owned by him, and that he has been given thirty (30) days to comply. Mr. Metzcus asked if he has contacted the City's Inspection and Planning Department regarding the other properties, as this is how the process gets started.
