Mr. Wulff added that salt is an issue but its effects can be counteracted with a good dose of iron in early spring.

# OLD BUSINESS

## **Review of Informational Flyer**

Board members reviewed the flyer drafted by Mr. Seilheimer using information from the Arbor Day Foundation. All agreed the flyer was well laid out and detailed.

Mrs. Boy provided a revised version of the flyer with a couple suggested changes of adding a section on Tree City as well as changing language from asking about the benefits to instead directing the public to the benefits listed on the website. Board members also liked the picture change which defines more of what an urban forest is.

Citing a statistic of percentile trees versus city population from a prior report of Mr. Seilheimer's, Mr. Wulff said Michigan City is in the 75 percent top range which is well above the national average and better than some of the best cities in the United States. All agreed this is unique to Michigan City and this statistic should be mentioned in the flyer.

Mrs. Boy pointed out that she also changed the color of the font. All liked the change and agreed it looked bolder.

Mrs. Boy said she would send her suggested changes to Mr. Seilheimer for his comments. She will also send a PDF to the board members for final approval.

Mr. Wulff commented that the edits looked good and asked Mrs. Boy to add the side notes as mentioned.

# **NEW BUSINESS**

Mrs. Boy stated that Councilman Don Przybylinski has questioned why the Tree Board is not asking the Council for more appropriations of tree money.

Board members indicated they would like to ask but felt this is not the time to do it with the budget situation.

Mr. Wulff pointed out that he thinks Mr. Seilheimer is doing a great job of getting State grant funds. He said what the board would ask of the Council is that when the City receives these grants that they provide the funding match. Mr. Wulff stated that matching funds are the best bang for the buck.

Mrs. Boy stated that she just wanted to make the board aware that Councilman Przybylinski was asking and that he is concerned about the streets.
