APPROVING ADDITIONAL APPROPRIATION FOR THE REINSTATEMENT OF THE POSITION OF ZONING ADMINISTRATOR IN THE PLANNING DEPARTMENT

WHEREAS, due to the retirement of the Zoning Administrator in the Planning Department and the provisions of Michigan City Ordinance No. 4097, the line item in the 2011 City Budget for that position will be eliminated and the position cannot be re-filled without an additional appropriation; and

WHEREAS, it has been demonstrated to the Common Council of the City of Michigan City that it is necessary to appropriate more money than was appropriated in the 2011 Annual Budget for the purpose of the reinstatement of the position of Zoning Administrator in the Planning Department; and

WHEREAS, the City Controller has determined that sufficient unappropriated funds are available in the General Fund #0101 to be appropriated for that purpose.

NOW, THEREFORE, BE IT ORDAINED by the Common Council of the City of Michigan City, LaPorte County, Indiana, that for the expenses of the City the following additional sums of money are hereby appropriated out of the fund named and for the purpose specified, subject to the laws governing the same:
