Application for Handgun License

1. The Michigan City Police Department will accept Application for Handgun Licenses on **Wednesdays ONLY - From 9:00 am - 4:00 pm**
2. Complete this application and return it to the Michigan City Police Department. Allow one (1) week for the Criminal History Check and then return to our Department on the following Wednesday.
3. When you return to complete your handgun license please bring two (2) Money Orders. One should be made out to the **Michigan City Police**. The other money order will be made out to the **State of Indiana**. The amount must correspond with the specific permit you are applying for.

* THE ENTIRE STATE FEE IS REFUNDABLE IF NO LICENSE IS ISSUED.

Note: the Personal Protection License also covers Hunting and Target License

4. You must bring proof of identification with you, preferably an Indiana Driver's License, or an Indiana ID Card, with your address on it. You must live within the corporate city limits of Michigan City. If you live outside the corporate city limits of Michigan City address you must apply at the LaPorte County Sheriff's Department.
5. Handgun License renewals may not be applied for more than one hundred eighty (180) days prior to the expiration of your current license
6. You may not have a Handgun License if you have been convicted of a FELONY, to include Felony D.U.I. (second offense of Driving While Intoxicated)
7. Any person giving false information or false evidence to obtain a Handgun License shall be deemed guilty of a Felony. Upon conviction, you may be punished by imprisonment for five (5) years to which a fine of \$10,000 may be added.
