The City of Michigan City is seeking a Program Manager to manage the day-to-day operations of its LeadSafe Michigan City Grant Program. This position will involve overseeing the implementation, day-to-day management, operation, and coordination with Program Staff, Partners, Contractors, and Grassroots Organizations. This is a 42-month limited grant position.

Duties: Perform project management duties which include: project design, site visits, reviewing and performing lead risk assessment oversight, housing rehabilitation, lead hazard control, contractor oversight, US Department of Housing and Urban Development (HUD) monitoring and reporting.

Function as a Lead Inspector Risk Assessor after successful course completion.

Monitor work in progress for compliance with job specifications, quality performance, and proper job management by contractors; and verify proper workmanship prior to submittal of payments.

Manage and intervene with the contractor and the owner regarding costs, compliance and industry standards.

Monitor quality control during lead hazard work to ensure grant compliance with description of work.

Assist Partners, Contractors and Grassroots Organizations with contractor and community outreach, training and participation.

Effective communication and coordination with Financial Manager, Project Director, Inspectors, Partners & Grassroots Organizations.

Prepare accurate periodic reports for submittal to the City, federal agency and/or funding partners.

Manage project data and conduct file reviews and compliance monitoring.

General administrative duties to assist the Lead Hazard Reduction program staff.

Participate in Grant-related trainings and conferences as required. Must be willing to travel.

Qualifications: Certified Lead-Based Paint Inspector and Lead Inspector Risk Assessor or ability to obtain within three months of hire, is required. Necessary training will be provided.

Experience in lead hazard control, housing rehabilitation and Healthy Homes assessments, is preferred.

Familiarity with the HUD Uniform Relocation Assistance and Real Property Acquisition Policies Act (URA), is required.
